Applications must be received by Friday, May 31, 2024. Class size is limited to 15 members. If you are not selected to participate in the current Leadership Montgomery County program, your application will be retained by the committee for consideration of later enrollment. All applicants will be notified of acceptance or non-acceptance.

The tuition fee for the Leadership Montgomery County program is \$525 per year, which may be paid by the individual or by a sponsoring company or organization. Tuition fees must be paid in full by Tuesday, July 1, 2024.

Class participants are required to attend three public meetings of government or organizations with which they have no affiliation. Also, each class will conduct a "class project" during the year. Class project will be determined by class members and approved by the LMC Executive Committee. One or more LMC executive committee members will serve as advisor to the class as they assess, plan, conduct & evaluate the project.
